PRESCHOOL FINANCIAL CONTRACT 2009-2010

Our Lady of Victory Preschool requires that each family makes a commitment to pay tuition fees on a regular basis. The obligation to pay tuition is legal as well as moral, and the School Board will turn over to a collection agency any unpaid accounts that have been proven uncollectable after reasonable attempts by the school.

REGISTRATION

Registration payments are a one time payment at registration time each year to cover student Diocesan assessments, books, insurances, etc. **Registration fees are nonrefundable.**

TUITION

Tuition will be due on the first of every month. Each family will be given their monthly tuition amount before beginning the preschool program. Any tuition not received by the 5th of the month will be assessed a late charge of \$15.00 and will receive an invoice for the late charge. Families will have two weeks after the 5th to bring their account current or the child will not be able to return. It is strongly encouraged that Enrollment for next school year will not be accepted from any family who has a balance from the prior year unless acceptable arrangements for payment have been made with the school office. It is a Diocesan policy that any family with a delinquent account in a Catholic elementary school cannot be admitted to another Catholic elementary school.

Returned checks have \$20.00 service charge and will automatically put you on a cash or money order basis after the first returned check.

FUNDRAISING

Fundraising is a necessary part of OLV School Community. Because of fundraisers and Scrip participation, we are able to continue to offer a comprehensive preschool program at the lowest possible tuition rates. The Scrip program is mandatory for full-time preschool families. The Cash Raffle and Volunteer /Participation hours are mandatory for all preschool families. Families who fail to meet their obligations will be charged per the contract. Please see the rates per hour / obligation on the back – under Parent Participation Responsibilities. All mandatory participation activities are approved by the school board and the pastor.
